I/WE HEREBY RELEASE, WAIVE, COVENANT NOT TO SUE AND DISCHARGE the promoter ,participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, drivers, rescue personnel, any persons in any RESTRICTED AREA, promoters, sponsors, owners, and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them , their directors, officers, members, agents, and employees, all for the purpose herein referred to as "Releasees," FROM ALL LIABILITY, TO THE UNDERSIGNED, my/our personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES, OR OTHERWISE WHILE THE MINOR IS IN OR UPON THE RESTRICTED AREA AND/OR COMPETING, OFFICIATING IN, OBSERVING, WORKING FOR OR FOR ANY PURPOSE PARTICIPATING IN THE EVENT.

I/we will inform and instruct the said minor participant that upon entering any RESTRICTED AREA the minor must be continuously thereafter inspect such RESTRICTED AREAS and all portions thereof which the minor enters and with which he comes in contact and I/we further warrant that the minor's entry upon such RESTRICTED AREA and his participation, if any, in the event constitutes an acknowledgement that he/she , (minor), has inspected such RESTRICTED AREA and that he/she finds and accepts the same as being safe and reasonably suited for the purposes of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in our about RESTRICTED AREAS and if he/she feels anything is unsafe, he/she will immediately advise the officials of such and will leave the restricted areas.
